**Disclaimer**

We acknowledge that:

1. We, as parents of the member student, NOT the Training Ground staff or instructors, are solely responsible for our child's home school education. Though our child may attend various enrichment classes and guest lectures at The Training Ground, we recognize that those activities are meant only to supplement the home instruction program provided by us parents. We understand the purpose of the center is to provide a variety of opportunities during the year to enhance our student's education with specific skills or high-interest classes, to offer unique teambuilding challenges, to enable our child to meet for clubs and guest lectures, and to help stimulate him or her to identify personal hobbies, goals, or career interests.
2. Parents are fully responsible for (i) seeing that their children are meeting NY State educational standards, and (ii) submitting the required reports and annual assessments to the students' local school district. The Training Ground is NOT responsible for documenting and reporting to the district student participation in or progress in programs offered at the center. The enrichment center does not make any reports to any school district about a student's IHIP or about any required assessments or quarterly reports. All IHIP responsibilities shall rest with the parents of the student. In addition, it is the responsibility of the parents to monitor their own student's progress at The Training Ground, to keep records for their student, and, if so desired, to report classes and activities that he or she determines to be complementary with their plan of instruction.
3. IN SO FAR AS a Training Ground class or activity enhances a student's homeschool program, the class may be listed with textbooks, field trips, etc. on the student's quarterly report, but no Training Ground course is intended to cover core curriculum requirements for any one subject, nor is it to be listed on the IHIP at the beginning of the academic year since Training Ground classes are subject to change. Furthermore, an appropriate Training Ground class or activity may be documented as instructional "hours" (used in the high school years to calculate transcript units) OR as an extra-curricular activity, if appropriate, but NOT as BOTH curricular and extra-curricular.
4. We have read and will abide by The Training Ground Policy Manual, including student code of conduct, student dress code, Statement of Faith, and parent parking rules.
